- **Journal Entry program features:**

- Document Id's assigned at time of update.
- Source code control, which defines origin of posting.
- Unlimited entry for document description.
- Unlimited entry GL accounts. (Defaulting capabilities from line above)
- Space for detail note per GL account line.
- Maintenance mode for documents not yet posted.
- Ability to Add, Delete, Insert, GL accounts to a document not yet posted.
- Displays Debit/Credit Sub totals in JE entry screen.
- JE's tracked by User Profile ID.
- Account entry lines default from line above.

Automated Import from Excel Spreadsheet. Maps data into our Journal entry file.

- **Reversing/Accrual Journal Entries.**

- Enter the initial JE and the system automatically creates the reversing entry.
- User chooses the Accounting period for the reversal.

- **Automatic Recurring Journal Entries.**

- User defined frequency for recurring JE, (Monthly, Quarterly, semi-annually, etc.)
- Prevents over postings by setting a limit to how many times the JE can be posted.
- Parameter flag that updates the same Dr/Cr amounts each time or wipes out the Dr/Cr amounts so that the user must enter them each time before posting.

- **Year End Close.**

- Can be run immediately at the end of the year. You don't have to wait for your auditor's adjusting entries to get meaningful financial statements for the next business year.
- Can be rerun as many times as needed. Re-running the procedure automatically reverses the previous closing entry as it creates the new one.

- **GL Account Allocations:**

- Direct: Enter a main allocation account and the system will automatically allocate based upon pre-defined percentages.
- Multi-Level: Allocations based on GL account groupings and percentages.

- **Standard Reports:**

- Ad-hoc Reporting. The user defines the sorting parameters and sub-total breaks. Example: Select all main accounts, for locations 1,4,& 10. Sort by main account, then by location. Sub total by the main account, sub total by location, or consolidate all (3) locations into a single summary line.
- User defined selection routines. (Selection routines allow the user to select single, multiple, range(s) or all items desired, such as main accounts or locations.)
- Trial Balances:
 - Information is selected for a specified period of time. (Example: As of a specific Month, Quarter, or Year to Date time frame)
 - Reports include Closing balances, Period Activity, Opening-Activity-Closing Balances, Transaction detail per Period, Transaction detail per Source/Origin code, and more.
- GL Detail per GL Account. (This displays the makeup of each debit and credit line in a document. Example of Detail items could be individual invoices that makeup a debit amount.)
- Reprint any GL document(s). Select by Document number, Fiscal Period, Source/Origin code, or by Document date.

- **Standard Inquiries:**

- Display Trial balance reports on your screen.
- GL accounts query displays Year to date balance, Period debit/credit activity and Period balance.
- Drill down on GL accounts to the debit/credit transaction level, subtotaling by source code.
- Drill down on GL accounts to the detail makeup of each debit/credit per transaction.
- Financial reports.

- **Financial Statement Reports:**

- User friendly report generator. This allows you to create financial reports in your own familiar formats. (You are not restricted to fixed formats.)
 - Easily create and maintain a single report format for all locations.
 - Complete flexibility allows nearly unlimited user-defined reports to be set up within each company. Once created, these reports can be printed on demand in both summary or detail formats.
 - Create Balance Sheets, P&L reports, sub-statements, or Per Location analysis.
 - Consolidations/Combinations: Flexible enough to perform multi-level consolidations between Locations or Companies.
 - Over 40 different columns of information that can be used in your financial reports. (Period actual, Year to Date, Budget, Prior Year data, comparisons, Custom columns and Variances, etc.)
 - Ability to perform multi-level calculations between columns, with ability to factor in literal numbers.
 - Complete Budget Analysis and comparisons. This year actual vs. budget. Additional feature allows budget amounts download from Excel.
 - Customized Import/Export feature to Excel spreadsheets. (optional)

 3 = Prints Main account and Location for each Detail Line.

- Functionality to download data into spreadsheets or word documents. (optional)
- Job Stream Financial reporting. Run reports one at a time, or create a job queue that prints out the desired reports in the proper distribution order. Preset your Monthly, Quarterly, or Year End reporting requirements to display the appropriate columns of information.
- Utilities - Master file copy utilities are available between companies and within companies, between locations, for easy setup.
- **Extra Features:**
 - Shadow/Xref company processing. (This feature allows you to process transactions in one company and link a GL account to a cross referenced GL account in another company.)
 - Security By User access:
 - Define default GL Company and Printer.
 - Define GL company(s) user can access.
 - Fiscal Period control. (Controls user to restricted fiscal periods.)
 - Security for program access.
